What is the Arizona Tax Credit Program?

Any individual may make a contribution or pay fees to a public school for support of extracurricular activities or character education programs. Arizona tax law allows taxpayers a tax credit of up to \$200 for single tax payers, or \$400 per married couple, if they contribute to extracurricular activities in public schools. *

What are Extracurricular Activities?

Extracurricular activities are school sponsored activities that require enrolled students to pay a fee in order to participate. Such activities may include, but are not limited to, use of band uniforms, use of equipment or uniforms for varsity athletics, use of scientific laboratory equipment or materials, or in-state or out-of-state trips that are solely for competitive events.
